DATA PRIVACY: Your personal data will be processed and stored in the UK by the Controller, International Management Group (UK) Limited of Building 6 Chiswick Park, 566 Chiswick High Road, London, W4 5HR, for the purposes of administering the Competition, notification of winning contestants and awarding prizes. We collect personal information you give us such as your name, address, social media account details and e-mail address for this purpose. We may also collect information about you if you register for an account or contest via a social media platform including Facebook, Twitter and Google+. TERMS AND CONDITIONS: By entering this Competition, you will be deemed to be bound by and have accepted these Terms & Conditions as well as The Big Festival's website's Terms of Use (<https://thebigfestival.com/festival-info/terms-and-conditions>). This Competition is open to all residents of the UK aged 18 or over except for employees of the Promoter (as defined below), or any member of its group of companies, their immediate families or anyone connected professionally to this Competition.

Definitions:

Entry means an Entrant's photo submission as further set out in paragraph 3.

Entrant means anyone who submits an entry to the Competition.

1st Prize means the prize described in paragraph 13.

Runners up Prize means the prize described in paragraph 14.

Competition means the Big Festival's Biggest Fan Competition 2020.

Prize Winners mean the winners of the 1st Prize and Runners Up Prizes as described in paragraph 12.

Promoter means International Management Group (UK) Limited

Terms and Conditions means the terms and conditions set out in this document.

Terms and Conditions:

1. This Competition will open on at 16:00 BST on 14/10/2020 and will close at 23:00 BST on 19/10/2020. Only entries submitted between this time period will be accepted.

2. No purchase necessary. Only one entry (which is limited to one photo) per Entrant will be accepted (one Prize per person) and all multiple entries may be void and the Entrant disqualified.

3. To enter the Competition:

a. Upload a photo of yourself with an explanation for why you deserve to win the title of 'Festival's Biggest Fan' on Instagram, Twitter or Facebook using the hashtag #festivalfromthefarm

b. To submit your entry, you can either upload the photo to your own social channels with the hashtag #festivalfromthefarm or reply in the comments section of our posts

4. The Promoter shall not be obliged to accept entries that are illegible and/or incomplete, and the Promoter reserves all rights to disqualify any Entrant(s) if his/her conduct is contrary to the spirit or the intention of the Competition or if any Entrant(s) breaches any of these Terms and Conditions.
5. Each Entrant must be the author/copyright holder of his/her submitted Photo. Each Photo must be Entrant's own work, must not be copied, must not contain any third party materials and/or content that Entrant does not have permission to use and must not otherwise be obscene, defamatory or in breach of any applicable legislation or regulations. If the Promoter has reason to believe a Photo is not an Entrant's own work or otherwise breaches this paragraph 6, then the Promoter may not consider it.
6. Each Entrant may only enter this Competition as an individual. Any entries which, in the Promoter's opinion have been made via participation in a syndicate, may be disqualified. Entries and/or Photos submitted on behalf of another person will not be accepted and joint submissions are not allowed. The Promoter reserves the right to verify the eligibility of Entrants at its sole discretion.
7. Promoter accepts no liability or responsibility for any entries (including Photos) that are lost, mislaid, damaged or destroyed.
8. Each Entrant is responsible for the cost (if any) of preparing his/her Photo and of submitting it to the Promoter as required in paragraph 3.
9. Promoter reserves the right to withdraw an entry (including any Photo(s)) from the Competition at any time if the Photo is deemed inappropriate for any reason.
10. Promoter reserves the right to disqualify any Entrant, or subsequently withdraw any award (including without limitation the Prize) if an Entrant is found to have breached any of these Terms and Conditions.
11. Entries should not contain any obscene, blasphemous or defamatory matter.
12. The Competition winners ("1st Prize Winner" and "Runners up Prize Winners") will be selected by an independent judge (in his/her sole discretion), and will be notified by the Promoter within one week via social media.
13. The 1st Prize Winner will receive the 1st Prize, where "1st Prize" means: (1) 4 Weekend Camping Tickets and 4 VIP Passes (which can be used for adults or children but the group must include at least 1 adult) to the Big Festival 2021 ("Event") ("Tickets"); and (2) the opportunity for the Prize Winner to appear on the main stage with the host at the Big Festival 2021 ("Event").
14. Runners Up Winners will receive the Runners Up Prize, where "Runners Up Prize" means: 2 Weekend Tickets to the Big Festival 2021 ("Event") ("Tickets")
15. The Prize does not include any expenses (including without limitation travel to and/or from the Event, overnight accommodation, drinks, or any spending money) and is non-transferable, non-exchangeable, and no cash alternative to the Prize is available.
16. In the event of the Prize Winners not being able to accept the Prize, no alternative or replacement Prize will be offered.
17. Promoter reserves the right to offer an alternative prize of the same or higher value, where it becomes necessary to do so, as decided by Promoter in its sole discretion.

18. In the event that the Promoter is unable to contact the Prize Winner within seven (7) working days, the Prize will be forfeited and the Promoter may select a replacement Prize Winner from the remaining Entrants. The Prize will also be forfeited if, at any time, the Prize Winner are found to have been ineligible to enter the Competition.

19. The Prize Winners will be sent the Tickets by post up to four weeks before The Big Festival event in August 2021 and the supply of his or her contact information, including name, address, email address and telephone number, and any information reasonably requested by the Promoter to ascertain the correct identity of the Prize Winner and the postal address to where the Prize is to be sent.

By entering the Competition, each Entrant is deemed to confirm and warrant that, to the best of his/her knowledge and belief, his/her general state of health is good and he/she has no relevant medical condition and is not taking any medication that could be adversely affected by any of the activities forming part of the Prize.

22. By entering the Competition, each Entrant assigns all rights in the Photograph and any and all accompanying material(s) to the Promoter for use by Promoter in its sole discretion, and Entrant shall have no rights in the same.

By entering this Competition and taking part in the activities forming the Prize each Entrant and his/her guests at the Event agrees to take part in or co-operate with a reasonable amount of related publicity or other promotional activity. Each Entrant further agrees that the Promoter may publish any photographs, films and/or recordings made by the Promoter which feature Entrant's name and/or his/her home town.

Failure to do so may lead to the immediate withdrawal of the Prize at Promoter's direction.

25. The Promoter is in no way liable for the reproduction or indirect access via third party web sites or home page access or where any reproduction of the information relating to this Competition misstates or omits any of the information or Terms and Conditions connected with the Competition.

26. Save in respect of personal injury, death or fraud, Promoter shall have no liability whatsoever to Entrants whether in contract, tort or otherwise, in connection with the Photo or entry or any other aspect of this Competition.

27. The decision of Promoter regarding any aspect of the Competition is final and binding in all matters and no correspondence will be entered into.

28. Promoter reserves the right to hold, void, suspend, cancel or amend the Competition if it becomes necessary to do so or if the Event is cancelled (in whole or in part), without any liability in respect of the same.

29. These Terms and Conditions, and all aspects of the Competition shall be governed by English law and shall be subject to the jurisdiction of the courts of England and Wales.
